#### 1. Background

Unique identity will greatly facilitate Ethiopia's participation in the African digital economy. The program was established with a vision of building a foundational identity platform for Ethiopia, proving that an individual is who he/she claims to be, in a secure, electronic, and sustainable way, to support all individual identity use cases for both citizens and legal residents of Ethiopia by 2025. It has also been strongly engaged in sustainable development due to its direct relation to development and implementation in the support of the digital transformation strategy of the country. The national ID program was established under the prime minister's office in September 2021.

One of the major objectives of the program is to enroll and provide authentication services and also transition to country rollout by the end of 2025. Therefore, in order to achieve this goal a pilot registration has been planned to start from the current fiscal year using a project-by-project approach. As a result, different use cases have been selected and discussions are undergoing to work together.

As a major part of the program, ensuring the legal establishment is highly essential to the overall successful implementation process. The National ID law is drafted and ready for submission to the parliament. Although, it is required to have public engagement and collect feedback beforehand. Therefore, NID office organized a workshop on March 11, 2022 at Skylight Hotel in order to present the draft and take expert opinion, especially from the legal community. The workshop will have a brief presentation and also an open discussion session.

#### 2. Objective of the legal Workshop

The objective of the legal consultation meeting was to provide a platform for stakeholders to learn about the National ID Program as it is being developed and provide their feedback. The consultation detailed the necessary legislative provisions and policy interventions required to enable a trusted, secure, and robust digital identity ecosystem in Ethiopia. It solicited input from stakeholders on how to best achieve this. This feedback will be used as input to further develop the legislation and overall program.

#### 3. Composition of Participants of the Legal Workshop

The attendees of the workshop were those who are directly involved in the legal departments of the Government and private sectors.

The workshop attracted the participation of 146 persons from regional, and federal governments, Civil Society groups and organizations, and representatives from international organizations, (The list of participants is attached in Annex 2)

The organizations attended the workshop includes representatives from the 10 regional governments and 2 city administrations, 34 federal institutions and NGOs, and 13 from local radio and TV

#### 4. Presented Topics

Two major presentations were made during the workshop regarding the National ID platform and the draft ID law. The presentations were made by Mr. Elias Debebe and Mr. Dilnesa Israel on the Digital ID Registration platform and Digital ID proclamation respectively.

#### 4.1. Officials Opening Remark

The official opening remark was given by H.E. Mrs Huria Ali, the state Minister for MInT. Her speech focused on the benefits of having National ID, including the importance of recognizing peoples identity for the improvement of public service. She also mentioned that the implementation of National ID helps citizens to exercise their right to be treated equally and get proper government services. Using of technology like digital ID will pave the way for digital transformation and transition to digital economy and will also contribute to the digital economy development. To this end the need for the preparation of legal framework and development of digital platform is a primary requirement to envisage the intended objectives of the National ID.

Introductory remark has also been made by Yodahe Zemichael the executive director of National ID Program . H.E mentioned that As stakeholders, the NID office have been and will continue to be active in helping create and foster a robust environment for the development of the Digital Identity System. For digital identity systems to be effective a legal and policy framework must be built on the basis of informed choice, consent & inclusiveness that guarantee data privacy and protection.

#### 5. Discussion

Based on the key topics covered in the presentation: enrollment, privacy, data ownership, inclusion, and digital authentication. Discussions have been made thoroughly in relation to policies, legislation, and regulations as required to define and enact a Digital ID System followed by an extensive Q&A session with active participation representing views from various institutions, sectors, and communities. Yodahe Zemichael introduced the participants of the workshop to the topic of national ID and the draft proclamation Some highlights of his introduction were about national ID and its practices in different countries and what the national ID program is doing in Ethiopia and the status of the draft proclamation

A "Question and Answer Time" chaired by Yodahe Zemicael, rounded off the day by providing participants the opportunity to question the NIDP panel. Some raised questions and suggestions are mentioned below.

Question/Comment	Answer/response
It is stated in the draft proclamation residents are not obligated to get a national ID. would it be possible for a national ID to fulfill its aim of registering 70 million people by 2026 if citizens were not compelled to take a national ID.	While citizens are not required to obtain a Digital ID, the authority that will be founded will be required to provide a national ID to people who come to the organization to obtain the ID. Services can set national ID as a requirement for their services and the liability will rely on the NID organization to give the ID. Making the ID mandatory would not ensure its success; as time goes on, and it becomes necessary for different services, the necessity for the ID will become higher.  Furthermore, persons who are unable to get functional IDs for a number of reasons can easily obtain a national ID and have access to government services.
Does the proposed law include provisions that address residents lacking supportive documents to secure their National ID that could exclude them from accessing essential services?	Is there a part of the draft proclamation that explains how individuals who do not have sufficient paperwork will be handled? Residents who do not have supporting papers can bring three persons who already have a national ID to serve as testimonies and receive their national identification.
Different terms are being used to refer to the ID. One is National ID and the other is Digital ID. what exactly will be the name of the proclamation and the ID.	This can be used as input, and more consultation and study into the name of the proclamation as well as the name of the ID will be conducted.
The proclamation states that data belongs to citizens and that National ID will ensure that the data is protected from third-party access, but it does not specify what penalties the organization would face if it fails to provide data protection.	The concern is appropriate and it will be included in proclamation

## 6. Major Achievements of the workshop

The major outcome of the workshop is the awareness created about National ID, the draft proclamations to stakeholders, and valuable feedback and recommendations were recorded.

Based on the feedback from the participants the necessary amendments were made to the ID law, and NIDP is preparing to have a second consultation with the public to get final feedback before the ID law is passed.
